## 2. Approval of Regular Agenda – April 10, 2023

#### 3. NEW Business

### A. OSS REVISED BUDGET – M. Denkler, Treasurer

Ms. Laura Simon observes that the budget for Old School Square has been adjusted according to the funding provided by the City of Delray Beach.

Ms. Vera Woodson shows concerns regarding the campus not having full time security team.

Ms. Laura Simon answers that during the day the DDA Safety Ambassadors patrol the area, and that overnight will be the time that a security team would be needed (the DDA Safety Ambassadors working daytime and evening hours only).

# B. Old School Square Foundation By-Laws and Overview - M. Denkler

Mr. Mark Denkler presents the item Old School Square Foundation By-Laws and overview. He explains that seeing that the DDA took over the Pineapple Grove Arts District, Inc., that was inactive, this 501 C3 organization can be turned into the future Old School Square non-profit, but first the old name needs to be changed on the Pineapple Grove Arts District, Inc. to be able for the Old School Square non-profit to be created and be associated with a bank account.

Ms. Vera enquires about who will be appointing the board members for the future Old School Square non-profit.

Ms. Laura Simon answers that the Foundation needs to draft the requirements for the composition of the future Old School Square non-profit board, and this board should include one of the DDA Board members. The DDA will oversee the activities of this board.

Mr. Frank Frione asks about how their fee was vetted.

Ms. Laura Simon answers that it is based on the budget.
